(Coronavirus)

(Flexibility of Local Authority and Police and Crime Panel Meetings) (England and Wales)
Regulations 2020, it is proposed that the following changes are made to Standing Orders until
May 2021 or such time as the government revises or revokes the legislation:

A person shall notify the meeting when requesting to speak by means of electronically notifying the meeting by using raising a hand facility
Voting on a question will be by each councillor giving their vote verbally, one at a time to enable the clerk to record the vote.....
