Following expressions of interest in speed monitoring in the Village the Clerk was asked to re minute details of the Derbyshire Constabulary CREST speeding initiative

Additionally it was now possible for members of the public to conduct their own speeding checks using equipment and training provided by CREST.

Any vehicles found to be speeding would be written to by the Police reminding them of the speed limits in the Village.

If the situation does not improve the Police would then conduct their own speed checks. For the local checks to take place a minimum of 4-6 villagers would be required to be trained and conduct the checks.

The Chairman also agreed to write to business owners reminding them of the speed limits throughout the Village.
